- **Free entry** if same SUV, Mini Van, or Mini Truck is ran in ACME Scramble on Friday night
- Minimum of 6 vehicles need to run this class
- Cash prizes contingent upon number of entries

ALL CARS MUST BE REMOVED FROM TRACK IMMEDIATELY UPON CONCLUSION OF DERBY EVENTS ON SATURDAY DUE TO RODEO SET-UP!
